MINUTES OF THE REGULAR MEETING OF THE SCHOOL BOARD INDEPENDENT SCHOOL DISTRICT 271 Bloomington, Minnesota

September 26, 2022

I. ROLL CALL

Pursuant to due call and notice thereof, and there being a quorum present, the School Board meeting of Independent School District 271 was called to order by Chair Tom Bennett at 7:00 p.m. on September 26, 2022, in the Arlene Bush Board Room at the Educational Services Center, 1350 West 106th Street, Bloomington, Minnesota.

Chair Bennett acknowledged that Bloomington Public Schools rests on the traditional, ancestral and contemporary land of the Dakota. The name of our state is Mni Sota Makoce, Land where the waters reflect the skies or clouds. Mni means water; Sota means clear, but not perfectly so, cloudy. Makoce means a place, land, or country. Recognizing the land is an expression of gratitude and appreciation to those whose territory we reside on and a way of honoring the Indigenous people.

II. PLEDGE OF ALLEGIANCE

III. APPROVAL OF THE AGENDA

Matt Dymoke moved and Dawn Steigauf seconded, to approve the agenda. Motion carried unanimously.

IV. RECOGNITIONS

National Merit Semifinalists The School Board recognized three National Merit Scholar Semifinalists. Dr. Jaysen Anderson, Jefferson High School Principal, introduced Charlie Grant and Adam Lueth. Ms. Molly Hollenbeck, Kennedy High School Principal, introduced Maisie Pederson. Students shared plans for the future and principals highlighted the students' accomplishments. These students represent the academic top one percent (1%) of all high school students in the country.

Student School Board Representatives

Student representatives for the 2022-2023 school year introduced themselves. Janie Andersen is a Jefferson senior and Kelly Olson is a Kennedy senior. Janie is serving her second year on the School Board and Kelly is serving her first year. Each student shared a brief biography including why they wanted to serve in this capacity.

Oath of Office

District Legal Counsel David Holman administered the Oath of Office to this year's student representatives to the School Board.

Student representatives will attend School Board meetings on the fourth Monday of each month and participate in discussion of Board meeting agenda items. Student representatives on the School Board are non-voting members. The student representatives will give reports about school activities. Also, as student representatives to the School Board, Janie Andersen and Kelly Olson will co-lead meetings of the high school representatives of the Board Student Advisory Council (BSAC).

Hispanic/Latino Heritage Month Proclamation Nelly Korman moved, Matt Dymoke seconded, that the School Board of Independent School District 271 approves the attached proclamation (on file) declaring September 15 through October 15, 2022, as Hispanic/Latino Heritage Month in the Bloomington Public Schools. Motion carried unanimously.

The observance started in 1968 as Hispanic Heritage Week under President Lyndon Johnson and was expanded by President Ronald Reagan in 1988 to cover a 30-day period starting on September 15 and ending on October 15. It was enacted into law on August 17, 1988, on the approval of Public Law 100-402. The School Board joins the Governor in proclaiming Hispanic/Latino Heritage Month for 2022.

The proclamation was accepted by Assistant Superintendent Dr. Jenna Mitchler.

Indigenous Peoples' Day Proclamation

Mia Olson moved, Dawn Steigauf seconded, that the School Board of Independent School District 271 approves the attached proclamation (on file) declaring Monday, October 10, 2022, as Indigenous Peoples' Day in the Bloomington Public Schools. Motion carried unanimously.

Indigenous Peoples' Day, also known as Native American Day, celebrates and honors the Indigenous Peoples of North America. On October 7, 2016, Governor Mark Dayton proclaimed the second Monday of October as Indigenous Peoples' Day for the State of Minnesota.

The proclamation was accepted by Assistant Superintendent Dr. Jenna Mitchler.

Student School Board Representative Reports Janie Andersen shared Jefferson activities and highlights: students enjoy being in-person in a normal school year, year kick off started with a pep fest, student led recognition of Hispanic/Latino month, homecoming activities begin the week of October 3 that includes homecoming coronation, spirit week activities, the homecoming football game and dance on October 7 and October 8 respectively. Student government encouraged voting for those 18 years old; the referendum renewal for safe and innovative schools is a question on the ballot.

Kelly Olson shared Kennedy activities and highlights: fall sports are well underway—soccer, football, volleyball; homecoming activities and spirit week begins this week that includes trivia night and movie night; many after school activities are scheduled; the homecoming football game is at noon on Saturday, October 1, with semi-formal homecoming dance that night.

V. SUPERINTENDENT'S REPORT

Superintendent Eric Melbye gave an update on how today went at Kennedy High School. Our district and school crisis teams met over the weekend, and some of those meetings included Bloomington police leaders to develop response and mental health support plans for school today, and additional planning for this week's school events, including the Kennedy homecoming game and dance on Saturday. I was on site at Kennedy this morning to connect with Kennedy leadership, staff and students. There were about a hundred students and several staff who took part in drop-in counseling and support. Additional support was provided to the football players and coaches in team settings. We are working closely with Bloomington police, Richfield Schools, and Richfield police to share information gleaned from the ongoing investigation and execute safety plans. Kennedy is looking forward to homecoming celebration activities throughout the week. I acknowledge Principal Molly Hollenbeck for her leadership, mental health supports and security teams, the football coaches and Kennedy staff for the comfort and care that has been displayed since the incident on Friday evening.

In the event of a school closure due to severe winter weather - snow, ice or dangerous wind chills - students will continue to learn from home as part of the district's Inclement Weather Learning Days Plan. We shared information last year and will share updated information soon about how these days will work for students and families. Inclement weather learning days have a specific purpose of replacing a no school day due to severe weather. Inclement weather days also alleviate the need for makeup school days in June.

Reminder to vote at the upcoming election on November 8. The ballot contains a question asking for renewal of the current safe and innovative schools levy referendum. Early voting began September 23; you may vote at Bloomington Civic Plaza.

The School Board and City Council are planning for a joint meeting on Wednesday, September 28, at 6:30 p.m. at Civic Plaza in the City Council Chambers. A motion to establish this meeting was moved by Dawn Steigauf and seconded by Matt Dymoke. Motion carried unanimously.

Proposed 2022 Payable 2023 Property Tax Levy Matt Dymoke moved, Heather Starks seconded, that the School Board of Independent School District 271 approves the property tax levy for the proposed 2022 payable 2023 levy of \$67,151,511. BE IT FURTHER RESOLVED, that in the event of any changes to levy amounts by the Minnesota Department of Education, it is the intent of the School Board of Independent School District 271 to levy the appropriate amount as allowed by law. The state requires that districts use the term "Maximum" on the certification sheet to allow these corrections to the levy. Motion carried unanimously.

Rod Zivkovich, Executive Director of Finance and Support Services, reported that the school district is required to certify a preliminary levy annually. Mr. Zivkovich reviewed the five levy categories in detail noting that the overall increase is 6.1% over last year. Median value homes increased 9.4% or \$359/year. The school district is required to submit this certified preliminary levy information to the County by September 30, 2022. The certified preliminary levy information will be used by the County to generate property tax notices that show parcel specific tax impact for each taxpayer in our school district for the coming year. These notices will be mailed in November 2022. The final levy will be certified by the School Board on December 12, 2022. This final certified levy information will be used by the County to calculate actual property taxes payable in 2023.

MAP, MCA III & Attendance District Results Dr. Julio Caesar, Interim Executive Director of Research, Evaluation and Assessment, shared the district results for the MAP, MCA III and Attendance. Results for the MCA III Reading and Math proficiency by grade and year and overall proficiency percentage were shared noting that after declines over the last couple of year, results are starting to show improvement in some grades. The same is true for MAP Reading and Math which indicates students achieving national growth targets. Information shared showed results by group and year and growth by grade and year. Attendance has been a large factor in the district results. The percent of students at or above 90% and 95% attendance rates by grade and year and by group and year is lower than in previous years. Results are consistent with what is happening in Minnesota and the country. Results for MCA Math and Reading (percent of students meeting or exceeding state standards) proficiency by attendance and grade and by attendance and group are improving. Each school's results are shared with the principal. With this information, steps are being taken to determine ways to improve student achievement. Superintendent Melbye shared that MAP test results were impressive. Improvement planning needs to focus on learning opportunities rather than learning loss.

School Board Goals 2022-2023 Heather Starks moved, Matt Dymoke seconded, that the School Board of Independent School District 271 approves its Goals for the 2022-2023 school year. Motion carried unanimously.

At the August 23 retreat, the School Board discussed and agreed upon its goals for this school year.
