Chair Starks acknowledged that Bloomington Public Schools rests on the traditional, ancestral and contemporary land of the Dakota. The name of our state is Mni Sota Makoce. Land where the waters reflect the skies or clouds. Mni means water: Sota means clear, but not perfectly so, cloudy. Makoce means a place, land, or country.
