

## MINUTES OF THE REGULAR MEETING OF THE SCHOOL BOARD INDEPENDENT SCHOOL DISTRICT 271 Bloomington, Minnesota

Pursuant to due call and notice thereof, and there being a quorum present, the School Board meeting of Independent School District 271 was called to order by Chair, Dawn Steigauf at 7:00 p.m. on August 12, 2024, in the Arlene Bush Board Room at the Educational Services Center, 1350 West 106th Street Bloomington, Minnesota.

COB Data Sharing Agreement

The District will collaborate with the city of Bloomington by providing de-identified data from the Bloomington Public Schools Annual Student Survey for inclusion in a summary

format within the Community Health Assessment (CHA). The primary goal of this data agreement are to gather additional insights into youth mental health for the CHA and to enhance services for Bloomington residents. Motion carried unanimously.

Nine Mile Creek Watershed Tom Bennett moved, Beth Beebe seconded, that the School Board of Independent School District 271 approves the cost share agreement with Nine Mile Creek Watershed District. Nine Mile Creek Watershed District (NMCWD) will contribute \$50,000.00 of the cost of the Raingarden design and educational outdoor space at Kennedy High School. One of the contractors Metro Blooms Design+Build will provide and be part of the site and landscape design of the enclosed courtyard space at Kennedy High School. The project goals include creating outdoor learning space and stations for students to explore Minnesota native plants and species, as well as small gathering spaces and quiet reflection spaces to be designed for well-being of students throughout the school day. GoFan

Mia Olson moved, Matt Dymoke seconded, that the School Board of Independent School District 271 approves the agreement between GoFan and Independent District 271. GoFan provides online digital tickets sales for high school athletics events through the GoFan® Solution. The digital tickets will be used at Jefferson and Kennedy High School's athletic events. There is no cost to the schools nor the district, and no credit card processing fees. There is \$1 convenience fee per ticket to the attendee. Attendees may search on a device for the GoFan site and find the school or download an app to access the ticket purchasing platform. Tickets are available, and redeemed on a mobile device by email or text or the GoFan app. GoFan replaces Vanco Events. Motion carried unanimously.
