Introduction

Why a Snapshot?



The October 1 snapshot describes our enrollment demographics at a single point in time, the actual recorded enrollment at the beginning of October. Historical trends have been included in this report to help illustrate our changing enrollment over the past 10 years.

Enrollment impacts many aspects of Bloomington Public Schools. The data shared in this report is intended to assist decision makers and interested citizens in creating and maintaining an exceptional educational system for all learners in our community.

Beginning in 2023, this report was expanded to include early learning services (ELS) and programs that serve students age 18-22.

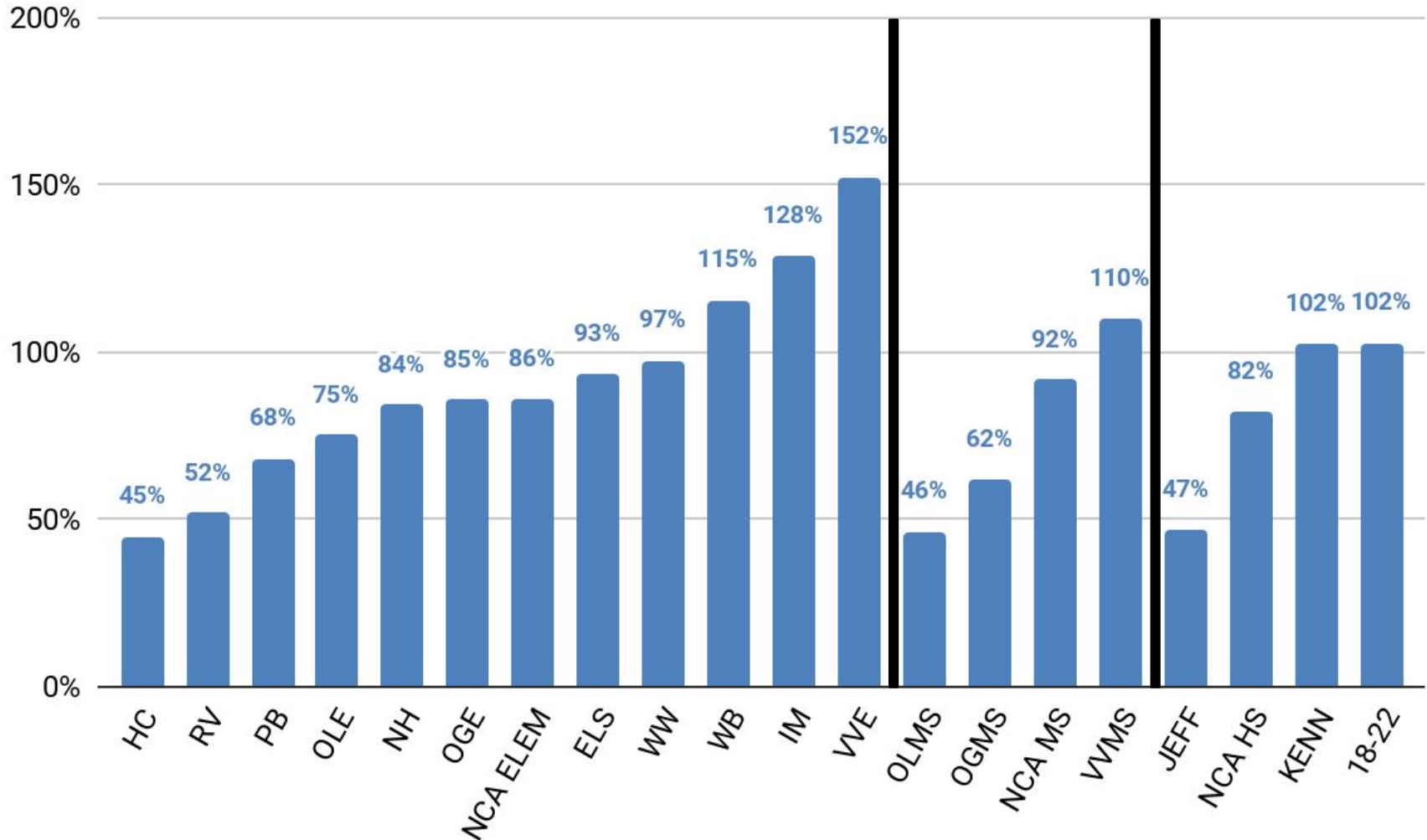

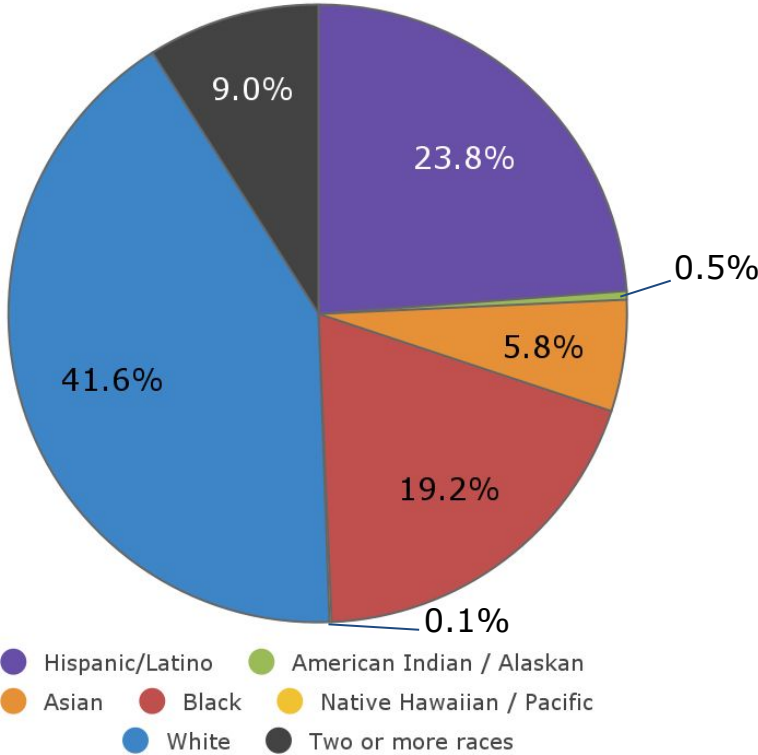
Demographic index = F/R eligibility % + English Learners % + Special Education %



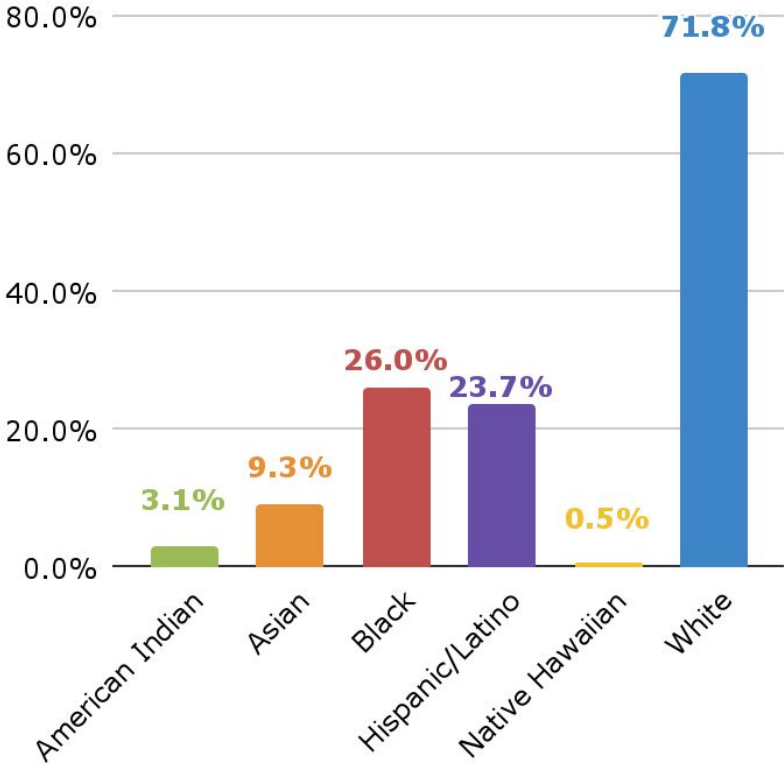
District Ethnic Diversity Profile

Federal Race/Ethnicity



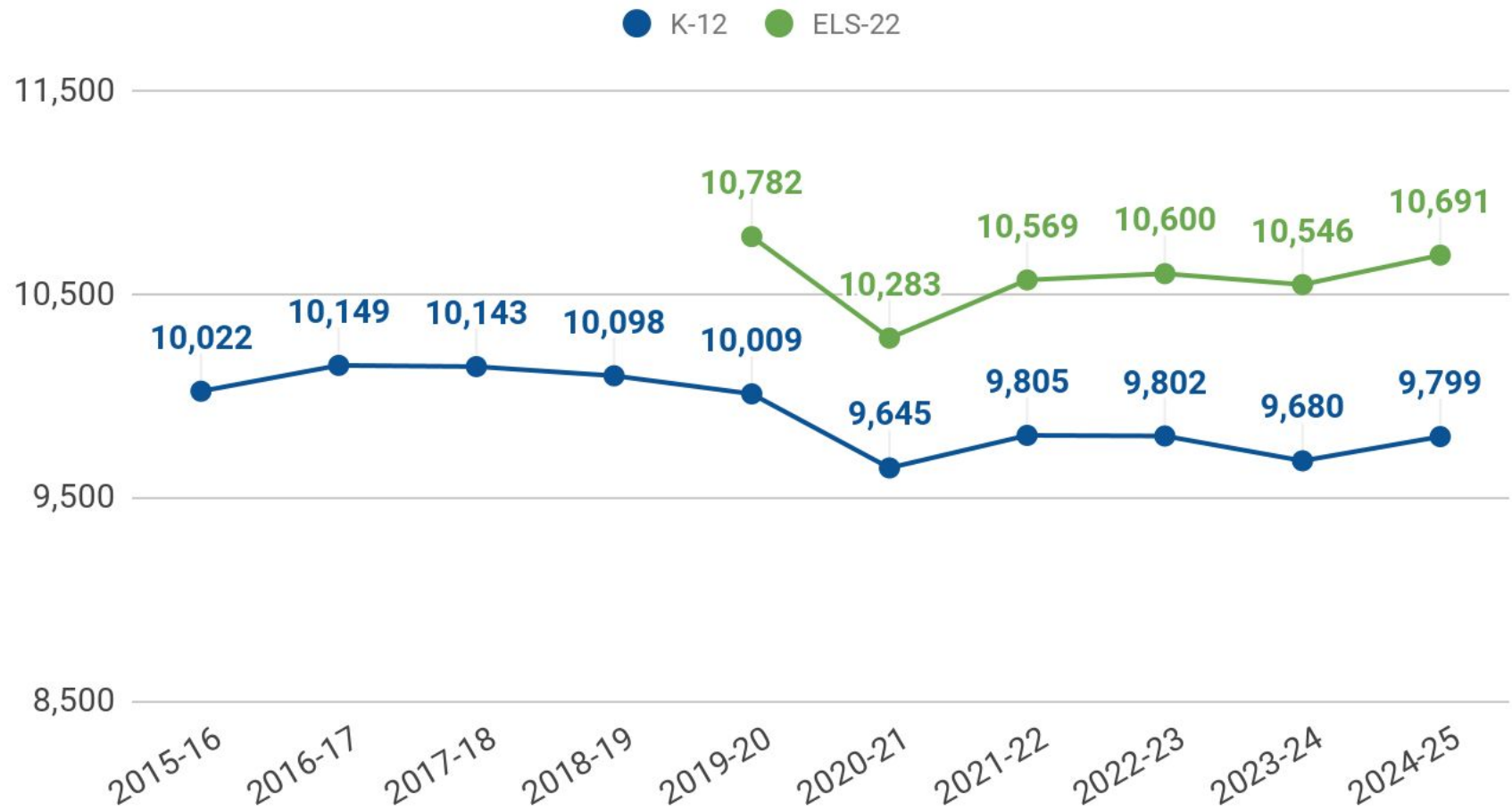

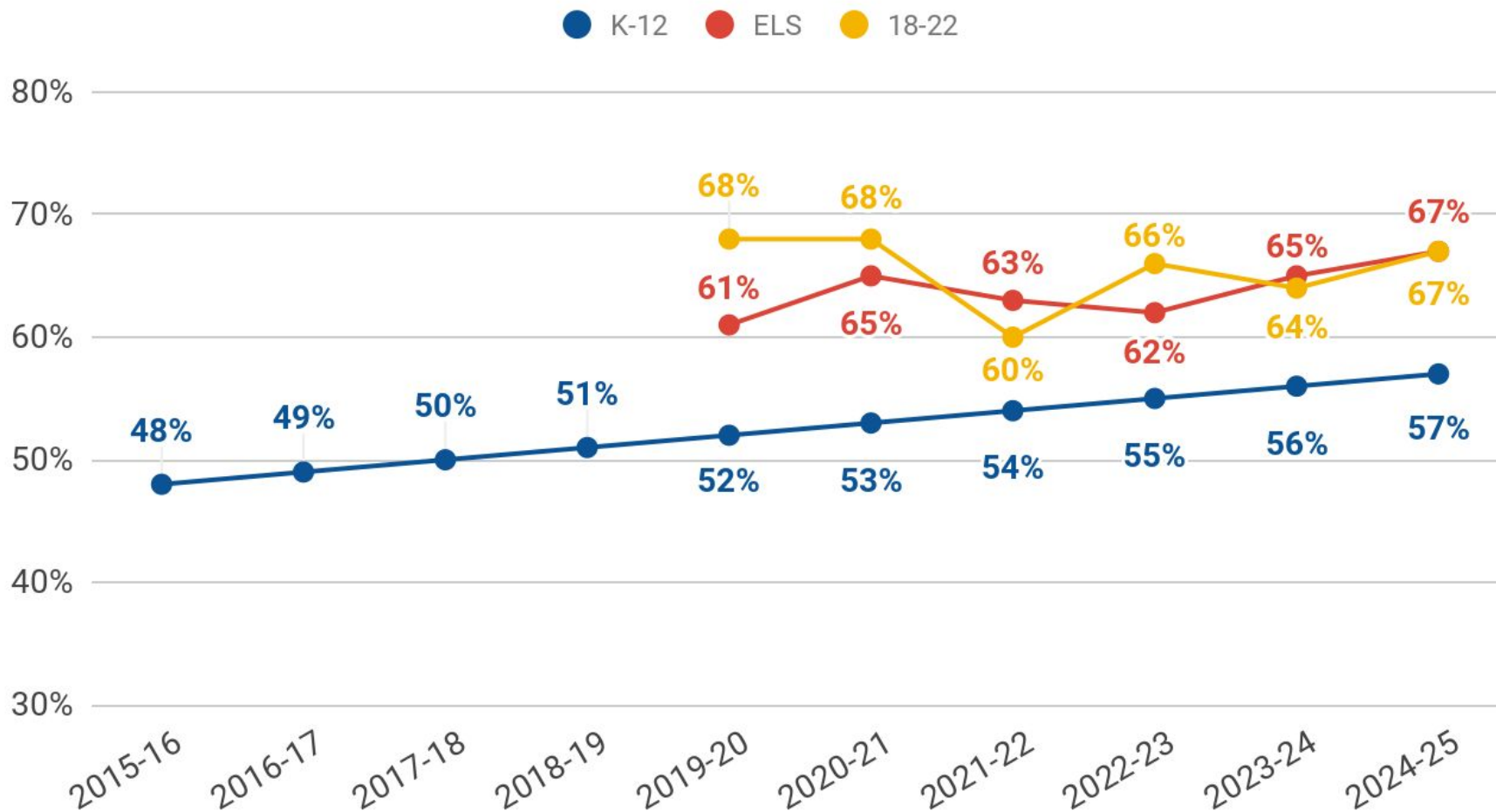


Enrollment – Past Ten Years

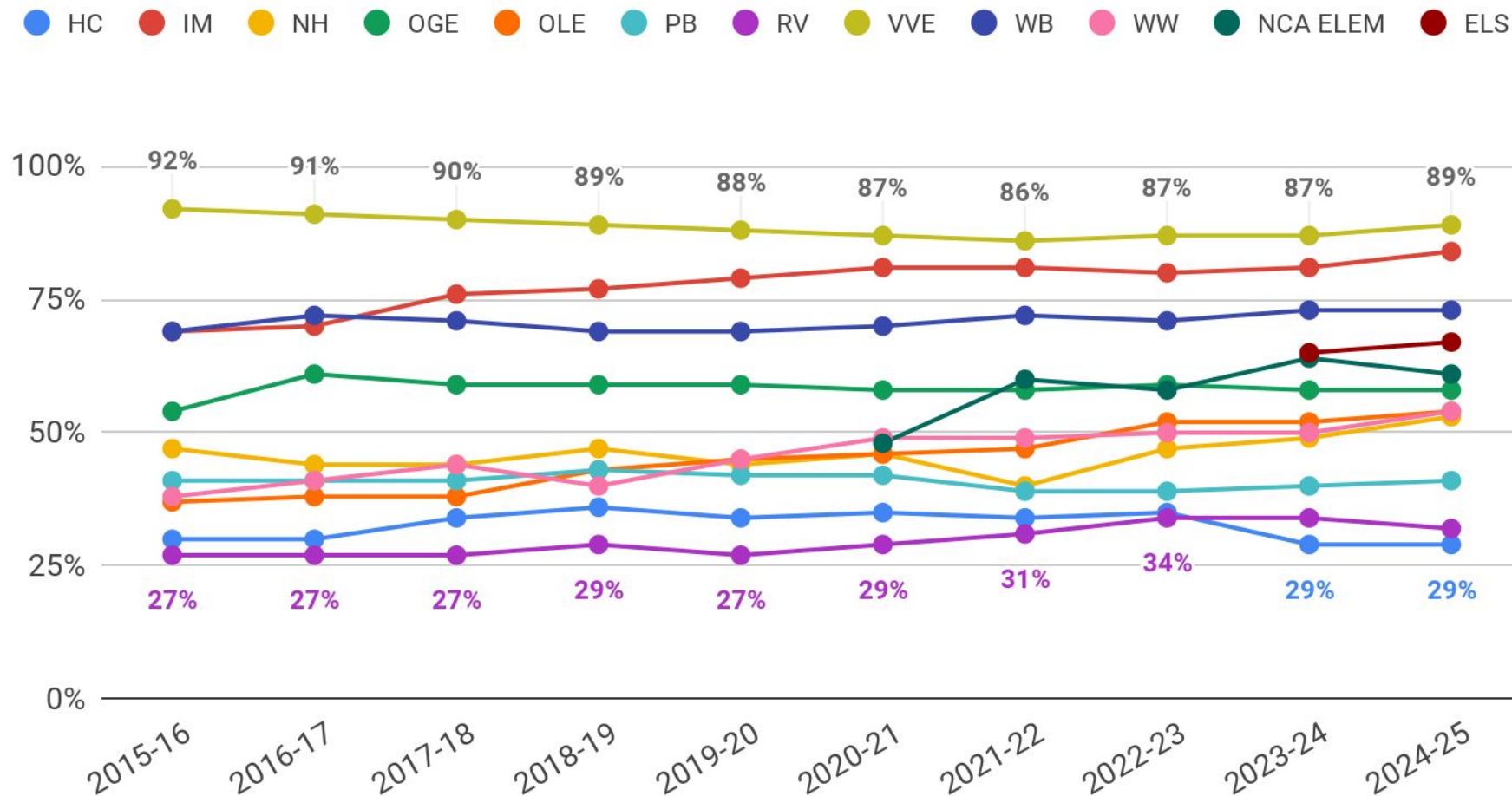

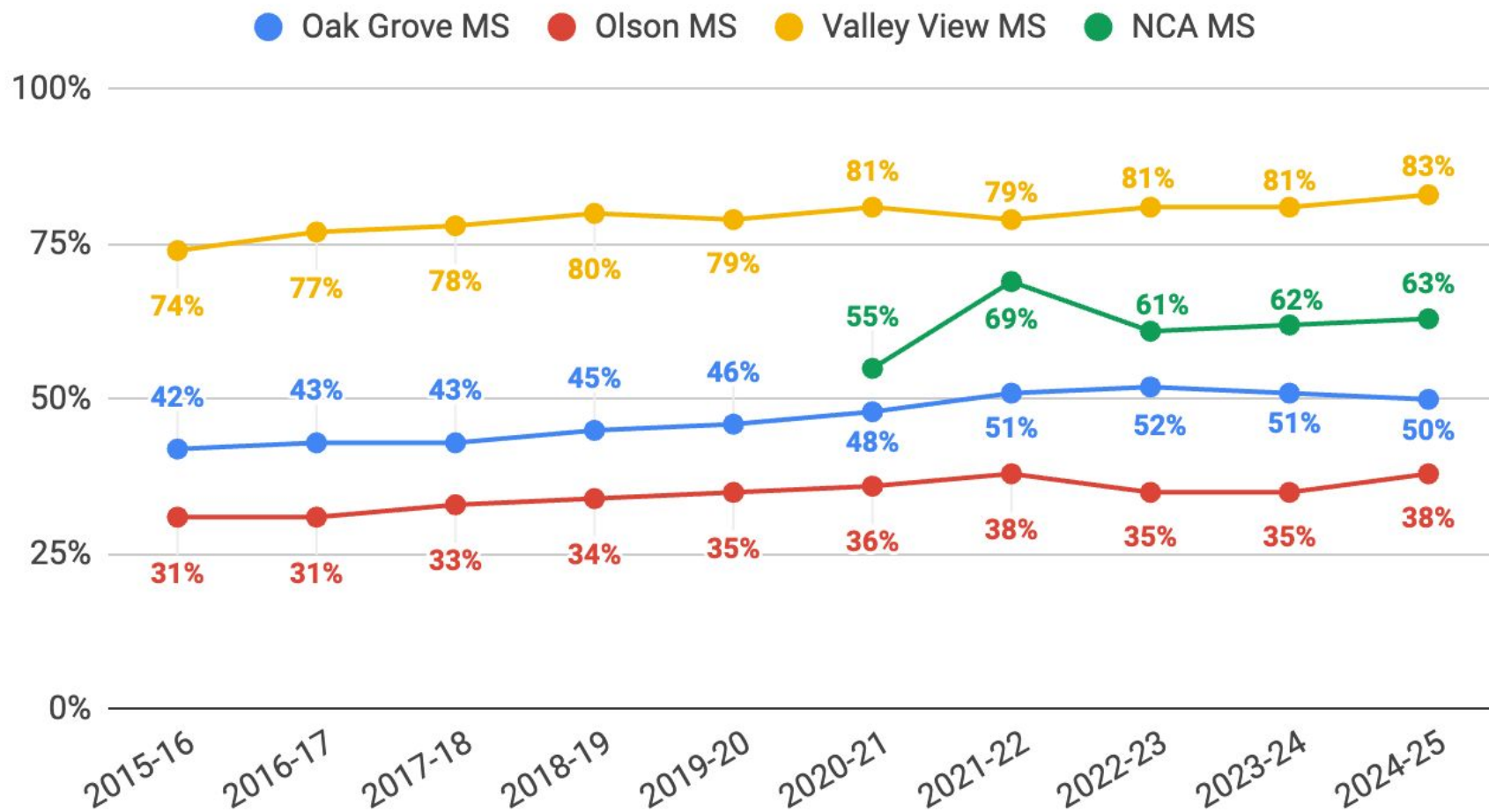
Early Learning (67%) & Elementary Schools (56%)

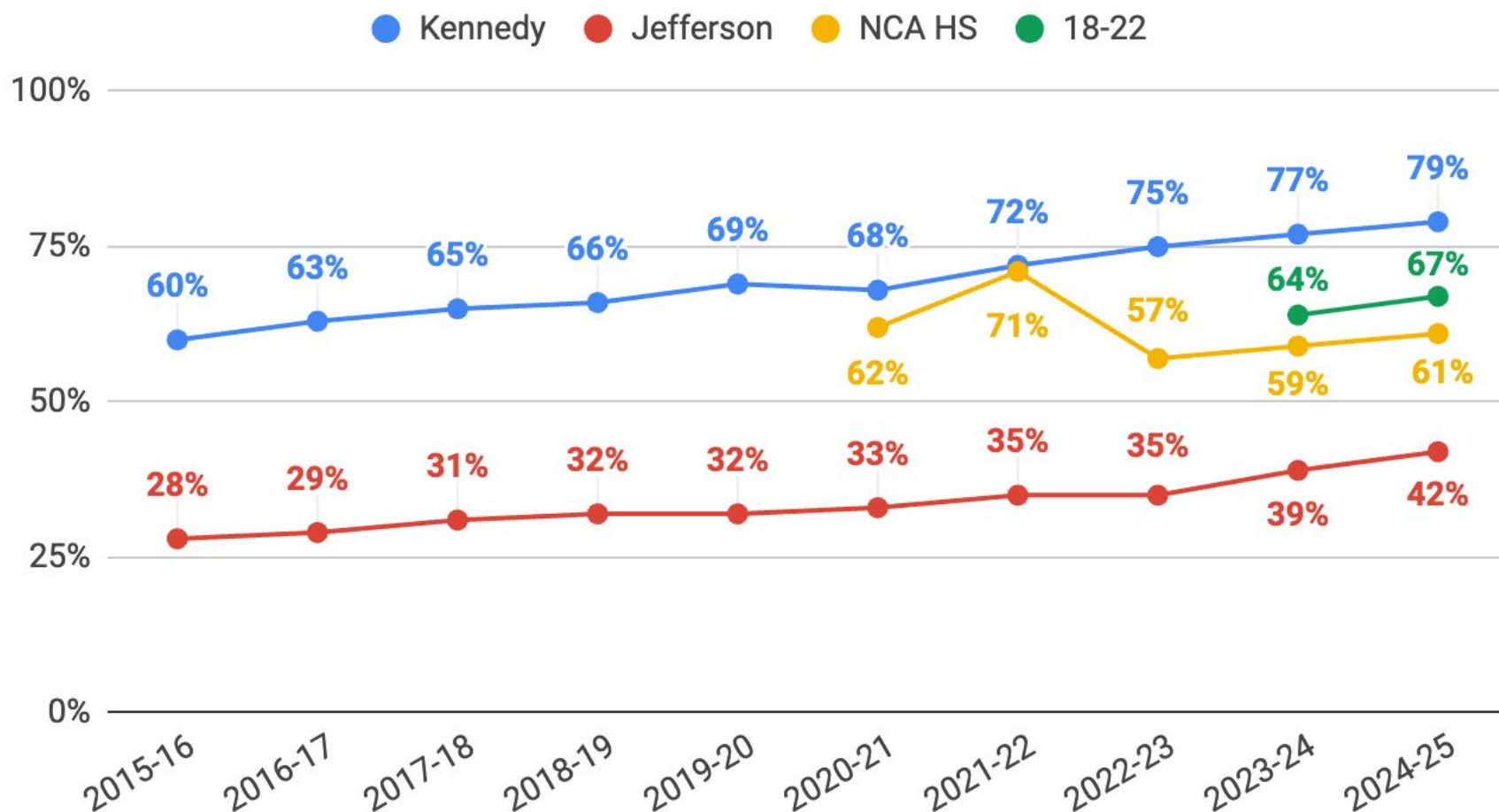
Middle Schools = 56%

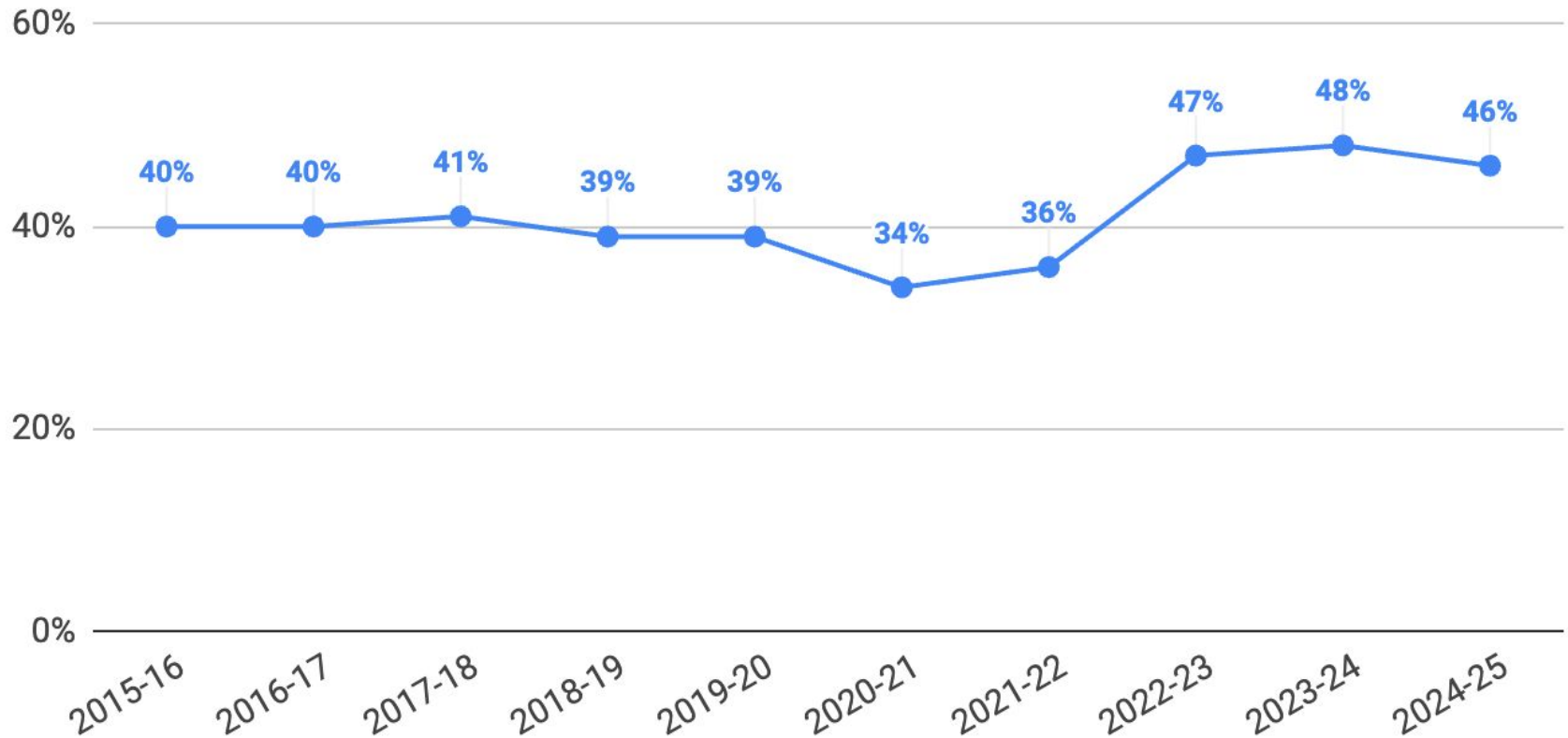
High Schools (60%) & Age 18-22 (67%)

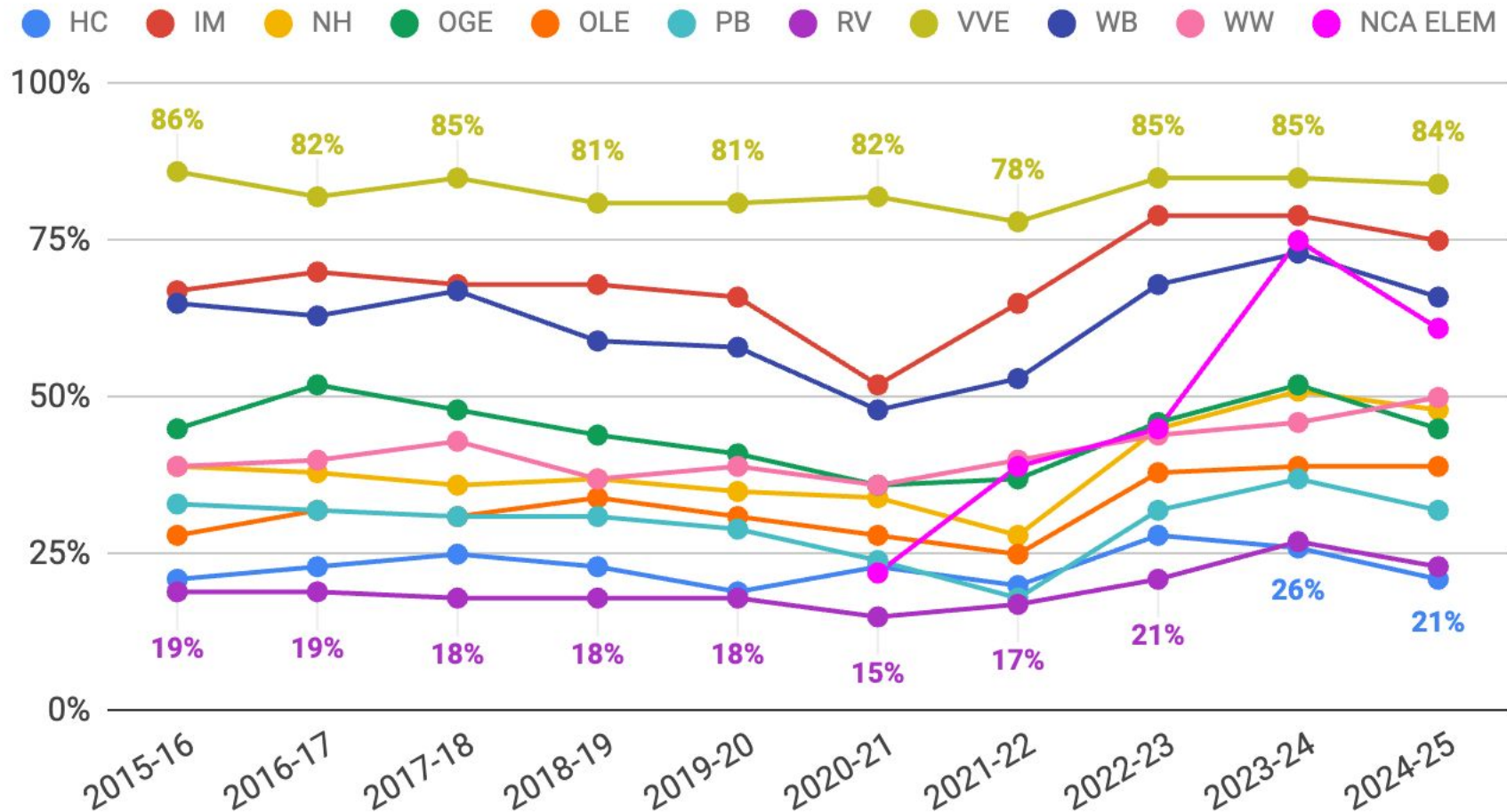
K-12 Schools – ten years

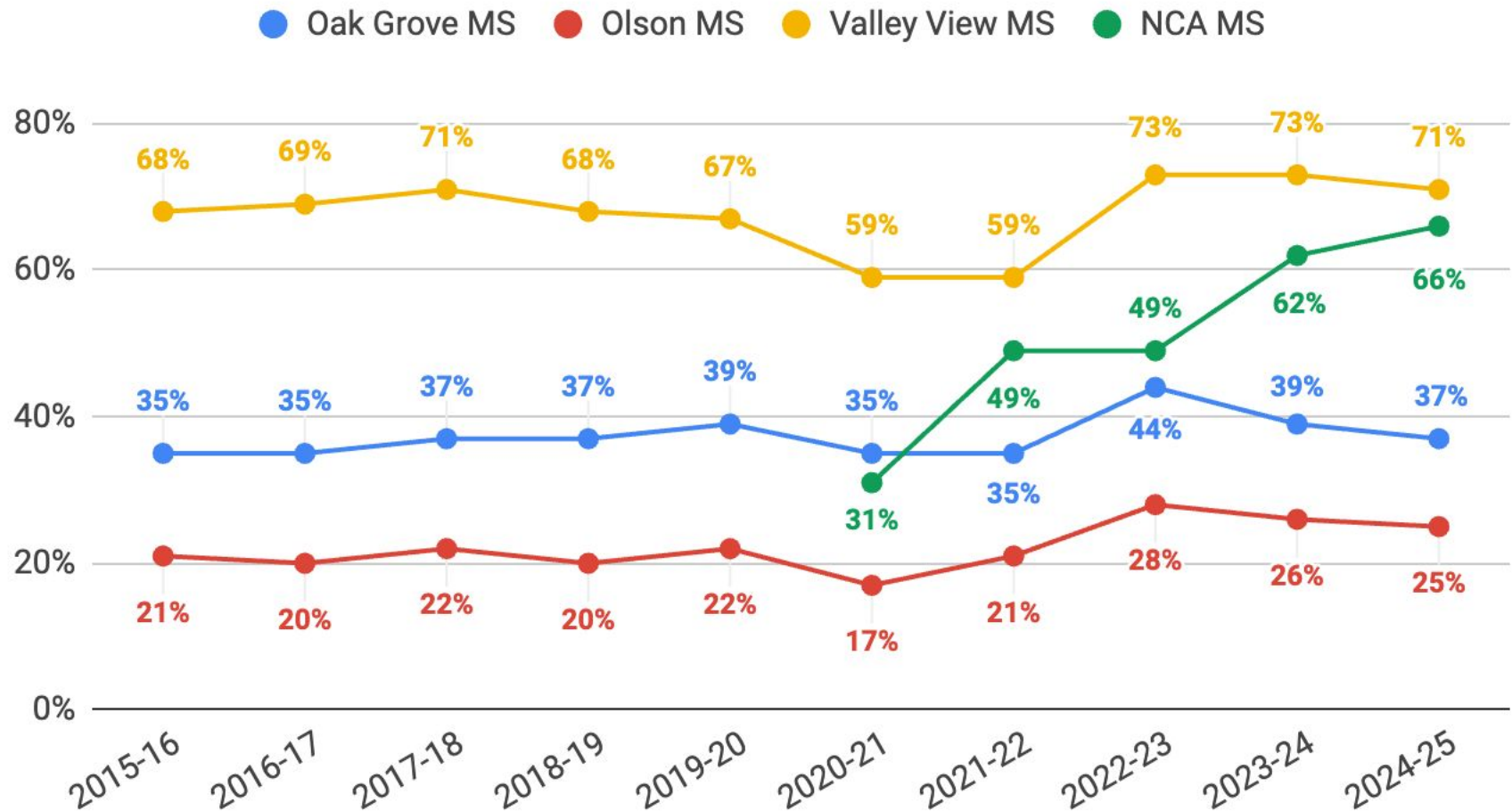

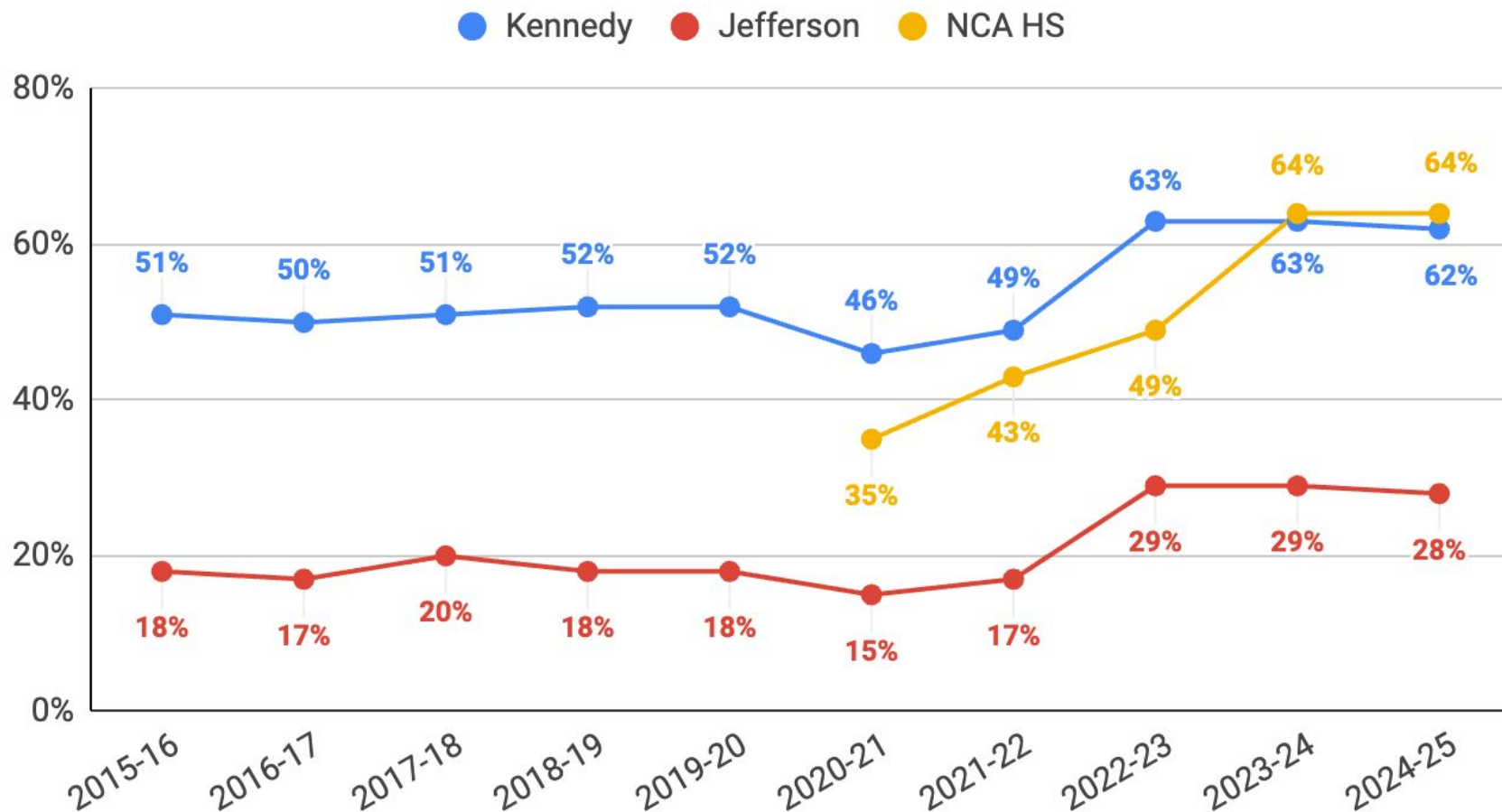
